

## Terms and Conditions for the University of Law Scholarships

These terms and conditions (these “**Terms**”) apply to all undergraduate and postgraduate scholarships (each a “**Scholarship**”) excluding any bursaries and other fee discounts made to students of The University of Law Limited (No. 07933838) (the “**University**”) commencing their courses between 1 July 2024 and 30 June 2025. These Terms cover the process of applying for and eligibility requirements for the Scholarships and your and the University’s respective obligations if your application for a Scholarship is successful.

Information relating to other fee discounts is available on the website ([www.law.ac.uk](http://www.law.ac.uk)) and will also be provided to you if/where applicable.

You should pay particular attention to the provisions of clause 19 of these Terms.

By completing and submitting an application for a Scholarship (an “**Application**”), you accept and agree to be bound by these Terms and any further terms and conditions which are specific to certain Scholarships and of which you are notified by the University (“**Further Terms**”). In the event of conflict between these Terms and any Further Terms, the Further Terms shall prevail.

For the avoidance of doubt, you remain bound by these Terms and any Further Terms in addition to the financial and contractual obligations of the University’s terms and conditions applicable to your enrolment on a course with us which are available on the website at [www.law.ac.uk](http://www.law.ac.uk) (the “**Student Terms and Conditions**”). If you accept your place at the University prior to the outcome of your Application, and your Application is unsuccessful, you remain liable for your course fees under the Student Terms and Conditions.

### Eligibility for a Scholarship

1. To be considered for a Scholarship you must meet the following eligibility criteria (the “**Eligibility Criteria**”):
  - (a) be an individual who meets the University’s admissions criteria (which may be updated from time to time) as set out on the University’s website;
  - (b) have received an offer from time to time from the University (which is

- (c) be able to meet all other living and other costs incurred during your course; and
- (d) meet any other further eligibility criteria relating to specific Scholarships, as set out on the University's website [www.law.ac.uk/study/scholarships-bursaries](http://www.law.ac.uk/study/scholarships-bursaries).

and the University strongly recommends that you submit your Application and Online Assessment (if applicable) at least a week before the relevant deadlines. The University is not responsible for and shall give no consideration to Applications which miss the relevant deadlines due to any IT or technical problems. The University is also not responsible for and shall give no consideration to any time lost during your Online Assessment or any failure to complete your Online Assessment as a result of IT or technical issues including, but not limited to, loss of internet, screens freezing or timing out.

7. You may not need to specify in your Application which Scholarship you would like to apply for, you will be automatically considered for all Scholarships that you are eligible for unless there is a separate application process. When you submit an Application, the University will (if you meet the Eligibility Criteria) consider you for any of the Scholarships listed on our website here: <https://www.law.ac.uk/study/scholarships-bursaries/>. As stated above, some Scholarships have separate application processes. This will be clear from the information available on our website.
8. You will not be eligible to receive both a Scholarship and any other award, bursary, discount or scholarship offered by the University (each an “**Award**”) unless it is listed in Schedule 1 to these Terms (the “**Permitted Awards**”). If you are successful in an application for both a Scholarship and an Award, you will receive only one of either the relevant Scholarship or Award, whichever has the highest value. If you are successful in being awarded both a Scholarship and any number of Permitted Awards, you will receive both the Scholarship and all of the relevant Permitted Awards.
9. Students who are eligible for and receive an Alumni Award (details of which can be found at <https://www.law.ac.uk/about/alumni/loyalty-scheme/>) are still eligible to apply for and may receive an Award under these Terms.
10. Your Application must be your own work and not contain any content or material which, in the University’s reasonable opinion:
  - (a) has been previously published or created by or in collaboration with any other individual;
  - (b) is defamatory, libellous, racist, homophobic, derogatory, pornographic, obscene, sexist, illegal, or otherwise inappropriate,(each being “**Forbidden Content**”). Failure to comply with this paragraph 10 will result in immediate disqualification of your Application for that Scholarship Year.
11. If your Application contains false or misleading information or any Forbidden Content, you will forfeit any right to receive a Scholarship from the University and you may be subject to further action in accordance with the University’s policies which are available at [www.law.ac.uk/policies](http://www.law.ac.uk/policies) including: withdrawal from your course; we may seek to recover from you the value of any Scholarship (or part of an Scholarship) already applied as a deduction from your fees; and/or you could face criminal prosecution.
12. By making an Application, you:
  - (a) confirm that the information (including, without limitation, information provided for the purposes of widening participation) is entirely true and correct; and

- (b) agree to provide such further information as and when requested by the University, or any authorities including but not limited to the UK Visas and Immigration and Quality Assurance Agency, in relation to any audit or investigation or when clarification on the information contained in an Application is sought.
13. Prior to the beginning of each Scholarship Year, the University will consider each Application which meets the Eligibility Criteria. Scholarships will then be awarded on the basis of this criteria, including the results of any online skills assessment, where applicable.
  14. The University will notify you of whether or not your Application for a Scholarship was successful or unsuccessful by email according to the response dates advertised on the University's website at <https://www.law.ac.uk/study/scholarships-bursaries/>.
  15. If your Application is successful and you have not already done so, you must accept your offer of a place on a University course within 7 days of being notified that you have been given a Scholarship. Failure to do so may result in the University withdrawing the Scholarship offered to you.
  16. All Scholarships are awarded at the sole discretion of the University and the University's decision shall be final.

### **Payment of your Scholarship**

17. If your Application is successful, you will have your Scholarship funds credited directly to your University account. The Scholarship funds will be applied to your final instalment payment(s) to reduce your payments of your Annual Tuition Fee (as that term is defined in your Student Terms and Conditions) by the Scholarship amount.

What happens if you win a Scholarship but decide to: defer, transfer or intermit your place on a course?

18. If your Application is successful and you subsequently decide to defer, transfer, or intermit your place on your course, your Scholarship may be deferred for a maximum of 12 months. If you do not return to your course within this period, your Scholarship will be forfeited.

## **Use of your personal data & publicity**

20.

27. The University may be responsible to you for foreseeable loss and damage caused by the University. If we fail to comply with these Terms, we are responsible for loss or damage you suffer that is a foreseeable result of our breaking these Terms or our failing to use reasonable care and skill, but we are not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time the contract was made, both we and you knew it might happen, for example, if you discussed it with us during the application process.
28. We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors; for fraud or fraudulent misrepresentation.
29. You must notify the University immediately of any change in your circumstances which may affect your eligibility to receive a Scholarship. If you fail to do so, the University will be entitled to recover or adjust (as appropriate) any Scholarship, associated Award or benefit. The University shall also be entitled to recover or adjust any Scholarship or Award given in error.
30. The University reserves the right, with reasonable cause, to exclude applicants from a course and/or withhold Scholarships for violating any of these Terms and/or any other applicable University policies or terms and conditions including (without limitation) the Student Terms and Conditions. The University policies are available on the University's website at <https://www.law.ac.uk/policies/>.
31. The University reserves the right to amend these Terms at any time. Any amendments will be published on the University's website and notification given to you of any such changes that affect you.
32. The University reserves the right to substitute your Scholarship with a different Scholarship of equal value in the event that circumstances beyond its control make this unavoidable.
33. Even if the University delays in enforcing these Terms, the University can still enforce them later. If the University does not insist immediately that you do anything you are required to do under these Terms, or if the University delays in taking steps against you if you break these Terms, it will not mean that you do not have to do those things or prevent the University from taking steps against you at a later date.
